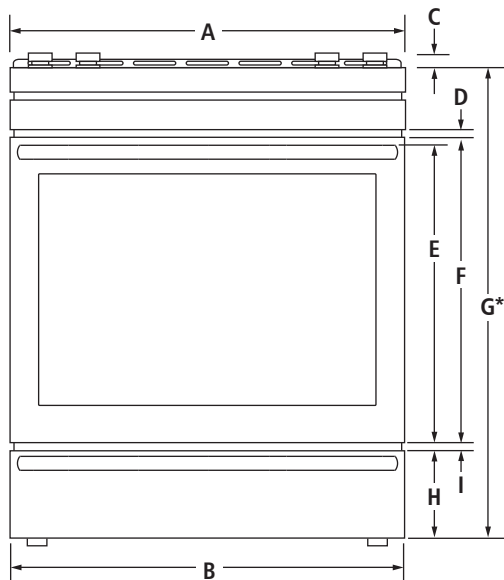

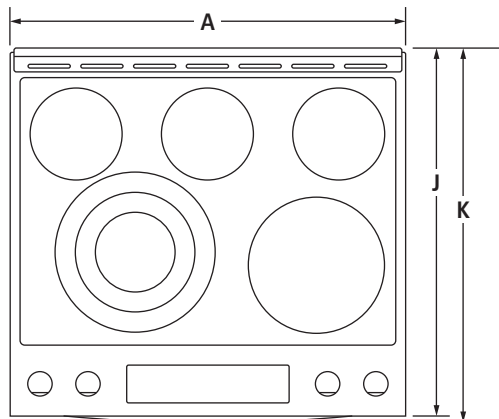

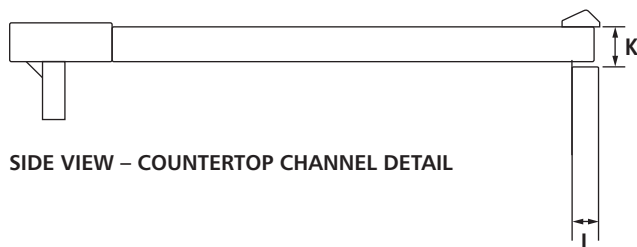

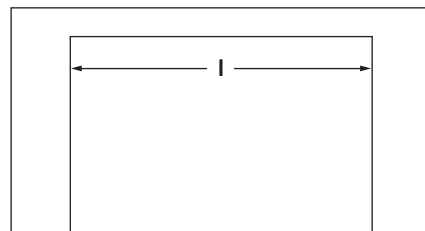
If installing a hood or microwave hood combination above the range, follow the hood or microwave hood combination instructions for dimensional clearances above the cooking surface.

ELECTRICAL REQUIREMENTS

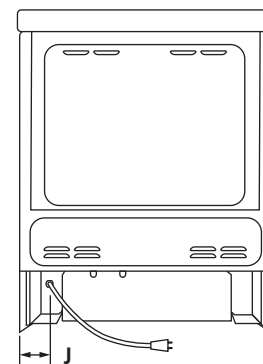
240 volt, 60 Hz, AC only, 40-amp fused, grounded circuit is required. A dedicated circuit is recommended. Minimum length of power cord is 48" (121.9 cm).
